When you’re ready to invest, you can choose from a variety of mutual funds found in the participant portal or mobile app. You can change your investment selection at any time 24/7/365.

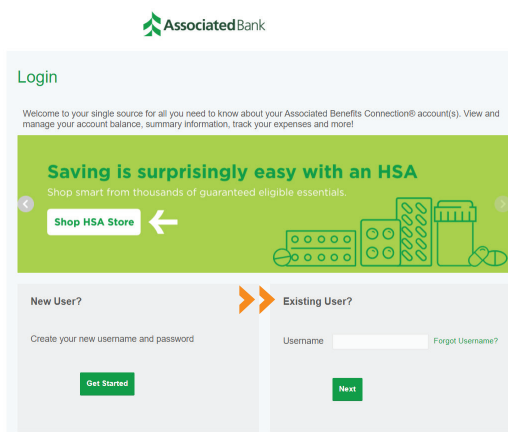
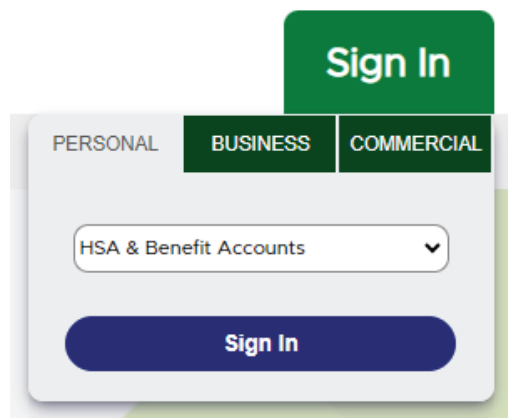

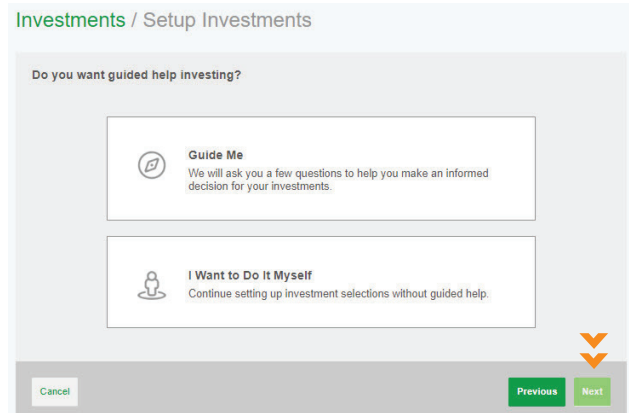
**STEP 2:** Under the “I Want To...” section, click **Manage Investments**.



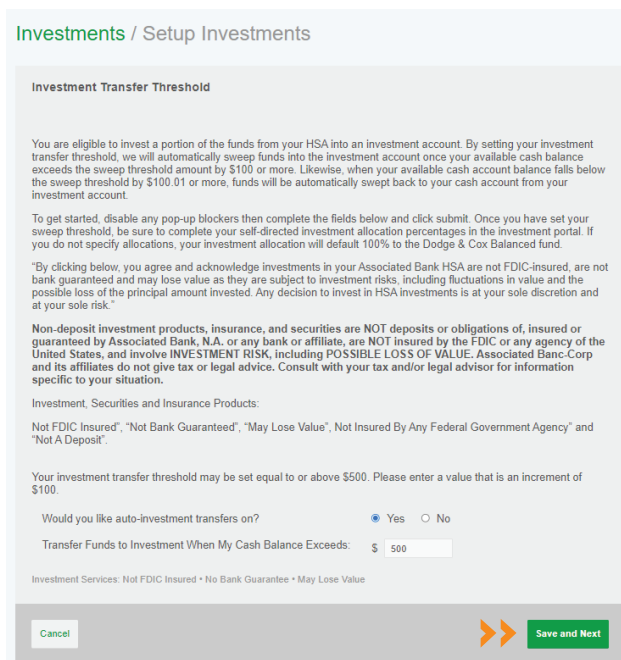
**STEP 3:** From here, click on **Start Investing**.
